

Types of Purchases

- Repayment of Refund(s)
- Purchase of Prior Service
- Out-of-State Law Enforcement Service
- Military Service
 - Military Service Relief Act
- Transfer of Creditable Service

Repayment of Refund

- Any member who withdrew from service & received a refund of contributions, and has once again become a member of the Pension Fund, may reestablish credit for refunded service.
- Member must pay back the refunded amount plus interest at the Boardapproved actuarial valuation interest rate (currently 7.0%) compounded annually.
- Only lump sum payment is accepted.
- If refunded service represents four or more years, the refund may be repaid in two separate installments.

Repayment of Refund

Without repayment of refund

- First eligible to retire at age 55
- Service credit at age 55 = 22.47123 years
- FAC = \$4,836.40/month
- Maximum benefit = \$3,622.62/month

• With repayment of refund

- First eligible to retire at age 55
- Service credit at age 55 = 27.94794 years (+5.47671 years)
- FAC = \$4,836.40/month
- Maximum benefit = \$4,505.58/month

• Was it worth it?

- Cost of repayment of refund = \$34,000.00 (19 years)
- Increase in monthly benefit = \$882.96
- Time to recoup cost = \$34,000 ÷ \$882.96 = 38.5 months
- Lifetime increase in benefits estimated to be \$286,079.04

Purchase of Prior Service

- Any member who has performed prior service as a sheriff, deputy or non-commissioned employee in a sheriff's office that has not been purchased or credited in the Fund, may purchase the service.
- The purchase of service is paid to the Pension Fund of an amount calculated by the Fund's actuary.
- Certification & documentation of the service, such as oaths of office and payroll records and/or W-2's are required.

Purchase of Out-of-State Law Enforcement Service

- Any member who has a minimum of 18 months of service in the Pension Fund.
- The service must have been full-time law enforcement service rendered in any other state.
- Cannot be receiving a retirement benefit or have the service in any other public retirement fund.
- The out-of-state retirement system will have to certify the service credit.
- The cost is based on the actuarial value of the service

A. (1) Notwithstanding any other provision of law to the contrary, any member who has at least eighteen months of creditable service in this Fund shall be eligible to obtain credit for full-time law enforcement service rendered in any other state, provided that service shall not be credited to this Fund if the member already has credit for that service in any other public retirement fund.

(2) In order to receive such credit, the retirement fund in which the member was enrolled while employed as a law enforcement office in another state shall certify, under oath, that the member does not have credit in that fund which duplicates the credit being purchased in this Fund.
(3) To purchase credit for such service, the member shall apply to the Board of Trustees of this Fund and shall furnish a detailed statement of all such service as the Board

and the amount paid shall be credited to the member's account in the Annuity Savings Fund.

B. The Board of Trustees shall promulgate rules and regulations regarding the amount of such service, which must be rendered to equal one year of credit in this Fund, but in no event, shall more than one year of service be credited for all such service rendered in any one fiscal year.

Purchase of Military Service

- To purchase regular (active duty) service, Form *DD214* is required to certify the period of active service
- To purchase non-regular (reservist) service, the form *Statement of Retirement Points* is required to certify the creditable points earned
- May purchase up to four years of either regular or non-regular military service or any combination
- The cost is based on the actuarial value of the service

Military Service Relief Act

- When a member is out on any type of military leave...the member has three options
 - A) Continue to pay employee contributions at an amount equal to the same amount the member would pay, had they never been called to military duty
 - B) Stop paying employee contributions and elect to pay employee contributions upon return of reemployment to the Sheriff's office
 - C) Never pay the employee contributions and the service will only qualify the member for retirement eligibility and NOT computation of benefits

Military Service Relief Act

- B) If member elects to pay employee contributions upon re-employment
 - There is NO interest on EMPLOYEE contributions
 - If member pays the employee contributions, the EMPLOYER contributions MUST be paid by the Sheriff's office, together with interest, at the Board-approved valuation rate
 - The member has three times the length of military service with a maximum of 5 years of reemployment with the Sheriff's office to repay the contributions
 - Member must return to Sheriff's office within 90 days of being released from military

The minimum requirement for regular retirement with the LA Sheriffs' Pension & Relief Fund is 12 years. Should a member already receiving (or eligible to receive) a military retirement benefit based on age and service OR a member currently drawing a disability benefit based on 25% or less disability received as a result of military service, wish to purchase up to a maximum of 4 years military service credit in the Sheriffs' Pension Fund, they may do so provided they were honorably discharged. Members already receiving benefits from any other LA public retirement system where military service credit was already purchased are not eligible for the purchase of military service within the Sheriffs' Pension Fund. Transfer of Creditable Service

- Combines the non-refunded service of two or more state, parochial, municipal or statewide retirement systems
- The member must have **12** months of current service with the Sheriffs' Pension Fund to be eligible for a transfer
- The transfer payment is comprised of employee and employer contributions in addition to interest
- The current retirement system assumes all liability of paying the future benefits & must receive an amount equal to the actuarial liability

Transfer of Creditable Service

- Member must complete transfer application with their CURRENT retirement system
- If the service in the other retirement system is refunded, they may want to contact the system to obtain the cost
- When the transfer calculations are complete, SPF will correspond with the member to notify them of all their transfer options

Transfer of Creditable Service

- Retirement without transfer of service
 - Date first eligible for retirement: August 1, 2016
 - Age at retirement: 56
 - Creditable Service: 12 years
 - FAC = \$5,672.98/month
 - Maximum benefit from SPF = \$2,269.17/month
 - Service in other system: 19.57534 @ 2%
 - FAC in other system: \$3,580/month
 - Maximum benefit from other system: \$1,401.59/month
 - Total combined benefit at age 56: \$3,671.30/month
 - Retirement with a pro-rata transfer (No cost to member)
 - Age first eligible for retirement: 55
 - Creditable Service: 11.05205 years @ 3 1/3% + 14.95937 years @ 2%
 - FAC = \$5,672.98/month
 - Maximum benefit = \$3,787.21/month
 - Additional 12 months of benefit = 12 X \$3,787.21 = \$45,446.52
 - Increase in monthly benefit = \$115.91
 - Lifetime increase in benefits estimated to be \$37,554.84

I also understand that if the funds transferred equal less then 100% of the increase in accrued liability to the receiving system, I must pay the difference to the receiving system.
I understand that my retirement credit, based on the creditable service transferred, will be calculated using the retirement percentage of the transferring system. I understand that after the transfer is completed, the transferring system shall have no future liability with respect to my creditable service transferred.

Upgrade of Accrual Rate

- Upgrade of the service credit accrual rate is available to member when a transfer of service is completed from another retirement system whose accrual rate is less than LSPRF's accrual rate of either 3¹/₃% or 3.0% for those hired after 1/1/12.
- The cost is equal to the actuarial value of the time being upgraded to LSPRF's accrual rate.
- This purchase can occur at any point in the member's career while they are actively contributing to LSPRF.
- To purchase the accrual rate upgrade, tax-deferred rollovers from deferred comp are accepted.

Purchase of "Lost" Transferred Service

- Purchase of "lost" service credit is available to a member when a member accepts the pro-rata amount of service in a transfer.
- The pro-rata service transfer occurs when the transferring system does not have enough funds to cover the liability of LSPRF for the total years of service the member held in the former retirement system.
- The cost is equal to the actuarial value of the time being purchased.
- This purchase can occur at any point in the member's career while they are actively contributing to LSPRF.
- To purchase the "lost" service, tax-deferred rollovers from deferred comp are accepted.

Permissive Service Credit – "Air Time"

- Must be purchased at the time of retirement
- May purchase up to 5 years of service credit
- To obtain cost, member must submit application
- Must have minimum of 12 years of service & retirement age eligibility to be able to purchase
- The cost is equal to the actuarial value of the benefits to be purchased
- On the day the service is purchased, the member will terminate employment & retire on the next business day
- Air Time serves 3 purposes:
 - Increase service for larger monthly benefit
 - Purchase eligibility
 - Purchase Back-DROP time to convert into annuity
 - Good way to roll over deferred comp into Pension Fund

Reciprocal Agreements

- Reciprocal agreement is the recognition of service in one retirement system by another system and involves no cost to the member
- Member must have 6 months of service for the agreement to be recognized
- Alternative to transfer of creditable service
- Member must submit application with their current retirement system
- <u>PLEASE NOTE</u>: Members must meet the HIGHEST standard of retirement requirements in EACH system to be eligible to retire
